## **OUR MISSION**

Bridges ends homelessness through volunteer-driven outreach and individual case management focusing on health, housing and independence. We form relationships with those experiencing homelessness while meeting their most urgent needs.



Dear Friends:

I'm thrilled to share that the attached publication shows a new look for Bridges – and perhaps more importantly, new language to describe the approach to our timely and necessary work. Our new logo displays a door opening in the “e”, representing both the doors which our teams open each and every day, and our ultimate goal to ensure every person in need has their own front door.

Having the ability to close and lock a front door of your own home represents both safety and security, which is missing for the unsheltered and even those with a sheltered existence. Further, our tagline: **Demanding Change. Ending Homelessness.** represents both the urgency and intensity of our daily work. Our professional Case Managers work daily demanding change across the very systems intended to help people who are experiencing homelessness. They refuse to accept that a person must sleep on the streets because safe shelter, or permanent housing are unavailable. Bridges believes that **one person experiencing homelessness for one night is an urgent crisis.**

Since the first days of the pandemic, the Bridges team was all hands on deck and we had to lean in, conducting a new kind of consistent Outreach. We have had more than **11,000** engagements on the streets – and have been lucky enough to partner with the City of Newark to facilitate hundreds and hundreds of shelter placements, connections to services, and enrollments in benefits – even housing vouchers! **We have been able to end homelessness more than 60 times so far.**

One of the most meaningful parts of this journey to date has been the overall community connection. It has been remarkable to watch the way the community has come together; helping those who experience homelessness; creating long-term, creative solutions for some of our most vulnerable neighbors.

Words cannot convey the gratitude we have for our generous and supportive friends in the community. In this report, I look forward to sharing with you the details and impactful growth we have made together since last year. I know that with your partnership and support we will continue to make outstanding strides in the coming months and years.

Thank you for your partnership. Together, we are ending homelessness.

# COVID Impact Timeline

During the first week of March, 2020, the first case of Covid-19 had hit New Jersey. By April 1, 2020 Bridges had a new Outreach and Engagement Team, working every single day, from 3:00pm-11:00pm, on the streets of Newark. At first the approach was binary: either you had a fever, cough, shortness of breath (or been around someone who did), or not. Yes – we get you health care – immediately. No – we’ll take you to a shelter – right now. Or better still – a hotel, with your own room, three meals a day, and on-site case management support. Media outlets were widely reporting that people experiencing homelessness were uniquely threatened by COVID-19 and suddenly, perhaps for the first time, tackling homelessness became part of a public health response. We became a different kind of front-line worker in the path of a global pandemic, and quickly learned that this work would become more important than we might have initially realized. After all, you can’t “stay home” if you don’t have one. And you are uniquely susceptible to this virus if you don’t have a front door of your own to close and lock to shield you from this pandemic.

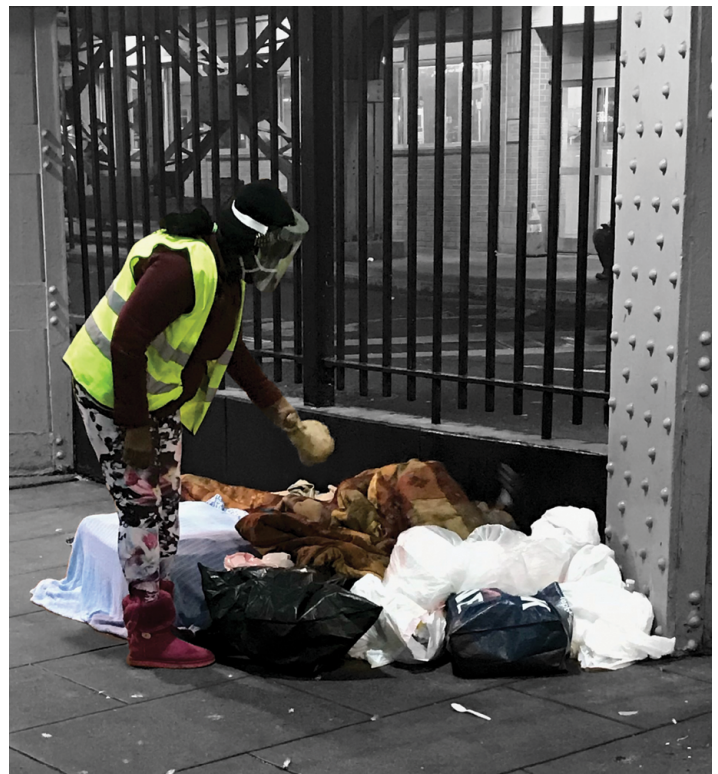

- MARCH 5, 2020** Suspended volunteer program on Runs, Using Staff Only
- MARCH 21, 2020** Runs to NYC are suspended
- MARCH 23, 2020** Bridges staff are fitted for N95 masks with the City of Newark
- MARCH 26, 2020** In just 1 week, Bridges staff had 154 interactions with unsheltered people in Newark, resulting in transport to shelter and medical care as needed
- APRIL 1, 2020** Daily outreach begins with new Outreach Specialists
- APRIL 3, 2020** Bridges holds first Virtual Town Hall to update community on Covid response
- APRIL 15, 2020** City of Newark opens Holiday Inn as a temporary shelter. Bridges assists 150 People off the street and provides transport to Holiday Inn
- APRIL 24, 2020** Increase to 5 Outreach Specialists for daily outreach 7 days a week
- MAY 5, 2020** Engaged with over 1,300 people since start of pandemic, transporting 372 to shelter and 195 to hotels
- MAY 9, 2020** Partnered with NJTransit to hold outreach at Newark Penn Station
- JUNE 27, 2020** Volunteers are invited back to Outreach Runs
- JULY 1, 2020** Almost 600 people placed into shelter to date
- AUG 21, 2020** Runs to NYC begin again
- SEPT 26, 2020** Bridges holds first virtual fundraiser, BridgeFIT, in lieu of its annual 5K, raising over \$26,000
- OCT 2020** Housing vouchers start to be approved for clients first engaged during Covid
- NOV 2020** Over 1,000 shelter placements and 22,000 lunches served
- DEC 16, 2020** Partnered with Summit area organizations as Summit Warm Hearts to provide winter shelter and food for 12 summit residents
- DEC 31, 2020** Over 7,000 outreach encounters with 1,185 shelter placements

- JAN 18, 2021** Bridges participates in first Virtual MLK Day of Service
- MARCH 5, 2021** Bridges is awarded 30 housing vouchers with Monarch Housing for housing development in the City of Newark, prioritizing the homeless
- MARCH 19, 2021** Partnered with City of Newark to assist with Newark Hope Village shipping container housing
- APRIL 1, 2021** Awarded \$100,000 by the NJ Pandemic Relief Fund for the second time
- MAY 5, 2021** Bridges holds virtual BridgeFest, raising over \$38,000
- MAY 20, 2021** Partnered with University Hospital in Newark for Trauma Recovery Center
- AUGUST 1, 2021** Partnered with Newark Equitable Vaccine program to help facilitate Covid and Flu vaccines for unsheltered population
- NOV 15, 2021** Seth Boyden Collaboration and Outreach Begins
- NOV 24, 2021** Count of unsheltered individuals in Newark hits 1,366 since January 2021
- NOV 30, 2021** 63 individuals housed since March 2020





# Daily Street Outreach Program Spotlight

## PROGRAM OVERVIEW

Bridges' Outreach Specialists are out in Newark 7 days a week from 3pm to 11pm trying to reach the vulnerable unsheltered population that need help outside of regular business hours. These specialists offer food, clothing, help with a shelter placement, vaccine information and refer clients to visit our Project Connect office for holistic case management.

At Project Connect, professional case managers work with homeless and newly housed clients individually to create an attainable set of goals that will lead to better health, and ultimately housing, a job and independence.

### BUILDING RELATIONSHIPS, STEPHANIE, CASE MANAGER

"I have been working with the homeless population for five years and in mental illness support services for over ten years.

Relationship-building begins with a conversation with the client. **Building that trust is the most crucial component.** As you converse, you begin to hear barriers, hone in on their priorities and which are most important to tackle first. Are they homeless living on the street? Are they in a shelter looking for permanent housing? Depending on where they are in the process determines the first steps.

For my newly-housed clients, the most critical hurdle can be transitioning them back into permanent housing. It can be a cultural shock to relearn how not to be homeless. To facilitate this, I try to have all furniture and supplies in the home when they move in. It establishes the space as their home and is a collaborative transition.

Once housed, we work on immediate needs such as finding income, obtaining a phone, building credit, solving any food insecurity, and connecting with needed services.

The satisfaction of building relationships and helping people get established in their new lives makes it worth it. "

# Outreach Donations and Runs Program Spotlight

## PROGRAM OVERVIEW

The Bridges Run is an opportunity for a group of trained volunteers, along with Bridges' staff, to go directly to the streets and shelters to meet homeless men, women, and children. On a typical Bridges Run, our truck is loaded with fresh, ready-to-eat meals in bags, sustainable lunches (long shelf life provisions), and soup, among other items of necessity, for those living on the street or in dire need. Our volunteers share conversation and bridge the gap between the housed and homeless.

Our tireless community of supporters from schools, religious institutions and community organizations provide lunches, hygiene kits, clothing and cold weather items that are given out every single day.

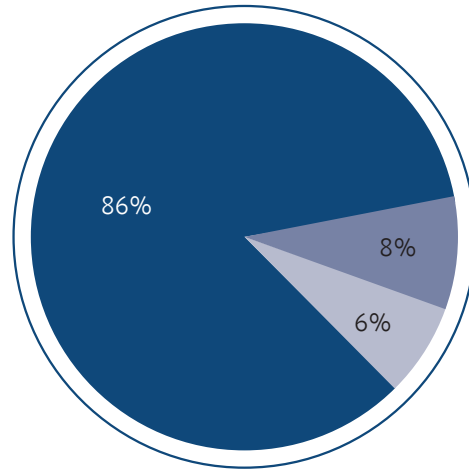
